Funding Measures on the June Ballot and Prop 13 Formula Funds

Zach Friend Second District Supervisor County of Santa Cruz This June, voters will have an opportunity to weigh in on a handful of funding measures for the unincorporated County that includes the Seacliff neighborhood. Following is an overview of the proposals, their purpose, and estimated revenues these would provide to the County.

Transient Occupancy Tax

Transient Occupancy Tax (TOT) is imposed by most cities and counties on hotels, motels, inns, and similar lodging establishments on persons staying overnight for thirty days or less. Typically, the lodging provider collects the tax from the guests and turns the funds over to the County or City. The County currently imposes an 11% TOT, which was approved by voters as a general tax. Together with local cities, TOT has been levied locally for more than two decades.

The last increase to the TOT was passed by voters in 2012, increasing the TOT in the unincorporated area from 9.5% to 11%, a figure arrived at after discussion with the Santa Cruz County Hospitality and Lodging Association and the Cities of Santa Cruz and Capitola.

Similar outreach was conducted this year to consider an increase in the TOT. If approved by voters, and with an effective date of January 1, 2023, this proposal would increase the County's TOT rate for hotels, motels, and inns from 11% to 12%, generating approximately \$160,000 in the first year and add \$440,000 to the base for FY 2023-24. For vacation rental properties, this proposal would increase the TOT rate from 11% to 14%, generating approximately \$700,000 in the first year and add \$1.9 million to the base for FY 2023-24. The additional revenue would be treated as part of the General Fund resources used to fund mandated programs and critical services that are not fully funded, such as public safety, parks, and public health operations.

Single-Use Cup Funding

The County currently imposes a single-use cup fee of twenty-five cents. This fee stays with the business that collects it - none of the funding reaches the County for environmental or other programs. The purpose of this ballot item is to propose splitting the fee so that half would stay with the businesses and half would go to the County.

This would not create a new or additional fee - but is simply asking voters if they support having 12.5 cents of the twenty-five cent charge return to the County for general environmental purposes including clean water protection, waste reduction, wildfire prevention, trash and litter clean up, maintenance of parks and public areas, environmental education, and other general services.

Property Tax Revenue From Proposition 13

I often receive questions about property taxes and how much of your property tax dollar remains in our county. Due to the current Proposition 13 formula, the County of Santa Cruz retains some of the lowest amounts of property taxes of any other in the state. Only 13% of your property tax

dollars end up back with County government to fund our local services. On average, this equates to \$463 of property tax dollars per resident. By comparison, Santa Clara County, under the same formula, retains \$10,831 of property tax dollars per resident, San Mateo County about \$4,500 and Napa County about \$4,000. Approximately 50 percent of residents live in our unincorporated county compared to approximately 4.5% in adjacent Santa Clara County.

As you can imagine, we hear questions about why in other California county's roads or services seem better, and one of the simplest answers pertains to how much of your property tax money stays with County government. If the Proposition 13 formula were to change in the future, unincorporated residents could see significant improvements to services and infrastructure without increased taxes by simply having more of your local property tax dollars stay with local County government. Action Required: Vote to Approve Seacliff Mini Park Path Refurbishment

It is time to redo the decomposed granite paths at the Seacliff Mini Park. We have patched holes and cracks for decades, and last Fall, the association board voted to put the job out for bid. The lowest estimate from The Landscape Company is \$3,767 so we are seeking approval for up to \$4,000 to cover unforeseen expenses.

Voting will take place at our first quarter membership meeting on March 15th, 2022, after our guests speak. See page one for RSVP instructions. We hope, with your approval, to install the new paths later this spring. We invite you to visit the Mini Park before the vote so you can see the current state of the pathways. Your dues also pay for periodic weeding, pruning, new plants and mulch. The last major project here was the replacement of wooden benches in 2013. The Seacliff Mini Park is located across the street from 162-170 Seacliff Drive above the state beach near the Moosehead trailhead leading to Aptos Creek.

Seacliff CERT was formed 12 years ago when members of the SIA Board took the certification training. It is now comprised of 14 residents and 2 nonresidents with training in basic disaster response skills, such as fire safety, light search and rescue, team organization, and disaster medical operations.

CERTs may assist others in their neighborhood following a disaster when professional responders are unavailable. In the event of a disaster, our Command Post will be located in the Community Center at Blue Pacific Mobile Home Park located on Mar Vista Drive. The park also maintains a building with our prepositioned equipment and supplies.

Currently, the Seacliff CERT team is working to establish a neighborhood communication network to support us when normal means of area communication fail. All you need is a MURS radio programmed to CERT frequencies. We are hosting talks and equipment

tests every Sunday evening at 7 pm and are working to establish coverage throughout Seacliff. You need not be a CERT member to operate the radio. Get a radio and join us in planning now and for the future. These programmed radios are available for \$50 from Team Leader, Mary Edmund at: medmund4@gmail.com

There are 10 CERT regions in Seacliff, each with approximately 250 homes. Full coverage requires 6-10 CERT trained neighbors, and with only 16 Seacliff volunteers, we need more coverage to adequately address emergencies. Our new CERT page on the SIA website: http://seacliffimprovement.org/c-e-r-t-community-emergency-response-team/ includes a map of these regions and the number of volunteers in each area. Please locate your region and consider joining the team. Training information and requirements are also located on this webpage. Having CERT volunteers acting as immediate responders to supplement fire, law and medical services is a vital resource in the case of natural disaster.

Rail Corridor Issues Create Confusion Ahead of June Ballot Measure

The Santa Cruz Branch Line, also known as the rail corridor, runs through Seacliff, and is used by many as a trail to reach Aptos Village and beyond. Formerly owned by Union Pacific Railroad, the line was purchased in 2012 by the Santa Cruz County Regional Transportation Commission, an autonomous planning agency that sets priorities for major improvements for our county transportation infrastructure. Initially purchased for a recreational trail and limited tourist train, the last ten years have seen numerous passenger rail studies for the entire line while freight traffic declined. Storms in 2016-2017 damaged bridges and other supporting structures disabling the route for rail use north of Watsonville. Estimated repair costs between \$40-60 million exceed current and future funding sources. Meanwhile, some segments of the trail have been built alongside the rail line in Santa Cruz and Watsonville.

For our association members registered to vote in Santa Cruz County, the upcoming election will include a local measure amending the county General Plan language regarding rail. The initiative focuses on pages 3-13 to 3-14, of the Streets and Highway section in the Circulation Chapter of the plan. It proposes use of the Santa Cruz Branch Line as an interim trail using existing rail structures for personal transit and recreation while preserving future rail options. Currently, the general plan language in this section primarily supports rail. The association has not polled our members to take a position on this issue, knowing there are many residents supporting both sides of this ballot measure. It has become very contentious and confusing for voters. One way to easily see the changes in the General Plan is to read them on the County Clerk Elections Department webpage:

On this page are the Notice of Intention to Circulate Petition and Certificate of Sufficiency for the Greenway Initiative Petition, named after the organization sponsoring the ballot measure.

Railbanking, a procedure used by freight line owners to legally use their corridors for other, non-freight purposes, is not part of this ballot measure. Railbanking is currently being evaluated by the Santa Cruz Regional Transportation Commission as an option to allow the trail to be built on private land eased to the commission for freight traffic only.
