#### SNAP (Seacliff Needs A Park) Update

The County of Santa Cruz is close to finalizing the purchase of 1.25 acres for Seacliff Park. The parcel is at the



corner of Sea Ridge Road and McGregor Road where it will have an ocean view. Supervisor Pirie and 1st District Supervisor Beautz used Prop 40 funds to purchase the land. We extend a big "thank you" to both Supervisors!

I, along with Niki Derby and Rebecca Downing, met with Supervisor Pirie and the Parks Director Barry Samuel in August. We were told, as of now, the County does not have enough money to create a park. After the purchase, there may be a bit over \$100,000 left. Unfortunately, the County will need a \$1 million or more to provide a full recreational park. As you can see, they are well short.

Director Samuel showed us design ideas that would fit this parcel. This was helpful when we discussed the money required to build Seacliff Park. As you can imagine, we were surprised at the cost. The Director stressed that you, the community, will ultimately decide what the park design will be through a process of public workshops scheduled for next year. The Parks Director is going to provide SNAP with a park facilities cost breakdown. At the community meetings, this will help all of us to decide what basic amenities we need in the initial phase and what can be planned for future phases. Supervisor Pirie promised to look for alternative funding sources.

Yes, progress is slow, but we are grateful that the children will some day have Seacliff Park where they can run and play, seniors can walk and visit, and all of us enjoy. We encourage you to contact Ellen Pirie to thank her for her effort in acquiring this parcel and to continue in her effort to find the necessary funding.

## **Upper Bluff Restoration Beginning** this Fall/Winter With Test Plot

Seacliff State Beach Upper Bluff restoration to native grasses, perennials, and wildflowers will begin with the start of the rainy season. This project has just been given a tremendous boost with the grant award of \$3,000 from the Monterey Bay Aquarium 2006 Conservation Action Fund. This grant was applied for in April 2006 and the award came as a happy surprise. Thanks to the Monterey Bay Aquarium for their generous grant which will help guarantee the success of this project.

Thanks for this award should also be given to those who started the plan by hiring Joshua Fodor of Central Coast Wilds. Two years ago, past presidents Glenn Larson and Harry Vaughn helped get the ball rolling with the encouragement and support of the members of the Aptos Chamber of Commerce Community Enhancement Committee, who include Gary Smith, Dave Vincent, John and Karen Hibble and Ellen Pirie. The Upper Bluff Committee is now lead by Dave Boggini and Adele Eberhart. Other active committee members include Steve Gibbs, Mary Gibbs, Bill Eaton, Sally Boggini, Patti Camarillo, Ramona Daniels, and myself

The Upper Bluff area of Seacliff State Beach is approximately 3 – 5 acres. The plan is to restore this area, over a number of years, to native grasses, perennials, and wildflowers. Currently, 90% of this bluff area consists of invasive plants. The State Parks, lead by Kirk Lingenfelter and assisted by Sarah Godfrey (who managed a similar restoration project at the Wilder Ranch State Park), will help guide the Seacliff Improvement Association in the native plant choices and the placement of the test plot.

We'll begin this season with a one-fourth to onehalf acre test plot located (as you face the ocean) at the far left corner closest to the ocean. As soon as the rainy season begins the plot will be plowed and hand weeded using the assistance of the California Conservation Corps and hand weeded again about a month later. In late December, the wildflower seeds will be strewn, and in late January the new grass plugs and perennials will be planted. Be sure and stop by to check out the various stages of progress. One of its best-known programs is "Operation Brown Bag," where fresh and packaged food is donated to over 2,200 members a week. Grey Bears hosts regular Potlucks and publishes a bi-monthly newsletter. They have an Arts & Crafts group that specializes in hand-made, one-of-a kind gifts. This group meets twice a month. The newest activity is Computer Refurbishing. This group converts donated equipment into working units and provides seniors with technical support to use these computers. They also run two full service-recycling facilities where they accept donations of food, money, recycling, volunteer time, clean clothing, small household items, and any recyclables taken at curbside.

#### **Seacliff Improvement Association Board of Directors Ballot**

It's election time for four positions on our board of directors. Following is the section of our bylaws pertaining to elections and the ballot.

#### ARTICLE V DIRECTORS

SECTION 1. Authority of Directors. Subject to limitations by law, the Articles of Incorporation, or the By-Laws of the Association, association responsibilities shall be exercised by or under the authority of the Board of Directors consisting of nine directors. Directors' terms shall be two years. Five directors shall be elected on odd numbered years, and four on even numbered years.

SECTION 2. Limitations of Directors. Individual Directors are not empowered to take public stands on community issues proclaiming representation of the Association's Board of Directors unless prior concurrence has been agreed upon by a majority vote of the Board of Directors. Before the expenditure of corporate funds or the incurring of any obligation in excess of \$1,000.00 in any single transaction shall be valid, such action of the Board must be approved by a majority vote at a general membership meeting.

SECTION 3. Qualifications of Directors. Only members in good standing shall be eligible to be elected as directors, and loss of good standing shall automatically declare the office of Director held by such person to be vacant. Candidates must have been a member of this Association for a minimum of one (1) year.
