
Final Public Meeting Held for the Streetscape Design

Seacliff residents received an update on the Utility Undergrounding and Streetscape Improvement projects at a recent county-sponsored community meeting. County Public Works Senior Engineer Jack Sorhiakoff reported that that a section of path was successfully redesigned and PG&E is now clear to trench down Coates Drive. Even more satisfying, the project cost has not changed. While these arrangements clear the path for utility undergrounding throughout the village, actual construction is still several weeks away and will last several months.


Jack also reported progress on the long awaited streetscape improvements. Once undergrounding is complete, surface level work can begin, thanks to cooperative design efforts by the department of Public Works and State Parks. For the two small state owned parcels at the southeast end of State Park Drive, State Parks' landscape architects provided designs that the County could accept and build. While State Parks retains title to the Seacliff Beach State Park entry, the design integrates the Park entry with the village's public plaza. Title transfer for these two lots is currently being determined.

An important part of maintaining the landscaping, once it is established, is paying for the water to keep the plants healthy. Mr. Sorhiakoff said Seacliff residents and businesses will need to pay for the water to maintain the landscaping. Our association will work with local businesses to determine a way to share the cost for maintaining the plants after they are established.



Meeting participants chose the single teardrop lighting style (see illustration) and wholeheartedly supported retaining the tree-lined median along Center Avenue included in the design. There was a

suggestion that low shrubs replace the trees to accommodate the mobile homes that are currently routed through the village. This idea was rejected by residents who feel our small village neighborhood should not have to sacrifice its improvements for wide loads travelling to other parts of the county. Since groundbreaking will not happen for months, this should give movers plenty of time to find another route.



Neighborhood Park to Break Ground in 2014

A couple dozen Seacliff residents braved the evening chill on November to hear representatives from the Santa Cruz County Department of Public Works describe the progress of the highly anticipated neighborhood park in Seacliff. SSA Landscape Architects, Inc. has been completing the existing plans for the park and will take the project through the environmental protection and development permit phase. If all goes well, there could be a ribbon cutting for the new park in 2014.


Representing SSA Landscape Architects, Scott Reeves briefly reviewed the McGregor Neighborhood Park

Master Plan, estimating a hefty \$1.4-million dollars will be needed to build the envisioned McGregor Park in its entirety. Mr. Reeves explained the economic issues and other factors supporting the firm's proposal that the park be constructed in two phases. After Mr. Reeves unveiled a conceptual drawing of the park's first phase, Assistant Public Works Director, Betsey Lynberg noted it was Supervisor Ellen Pirie's unflagging advocacy for the neighborhood park that persuaded the SC County Board of Supervisors to approve \$650,000 toward construction of the park's first phase.

Most of Phase One focuses on the northern section of the 1.25-acre park. Drawing guidance from the Master Plan, Mr. Reeves described the park design

as dotted with drought-tolerant trees and shrubs with a small mowed area where the future 'skateable art' pieces will someday be installed. Phase One includes a fenced tot lot with benches and two sheltered picnic tables nearby. Sewer and utility lines will be stubbed in for the future bathroom, but until then, a portable restroom will be maintained by Parks Staff. Seacliff neighbors suggested reprioritizing some park elements including a new sidewalk along the East parameter of the park for pedestrian safety next to McGregor Road. Other priorities attendees identified included the need for security lighting to discourage loitering in the park after hours, a hand wash station near the portable restroom and a well-stocked doggie-bag station. Although the park is

currently referred to as McGregor, the county still seeks an official name. What do you think it should be called? The county wants to hear from you!



Proposed Scenic Rail Trail Runs Through Seacliff

Upon completion of the rail line purchase from Union Pacific Rail Road, the Santa Cruz Regional Transportation District (RTC) held a Whistle Stop celebration and a series of public meetings to present the master draft plan for the scenic rail trail project. Because the scope of the plan is very large, twenty segments were created to more easily organize the route to prioritize construction. Segments are defined as potential trail projects with logical beginning and end points with the intent that each segment will be funded, designed, and constructed as a whole.

Segments 11 and 12 run through Seacliff with Segment 11 ending at State Park Drive where Segment 12 begins. As the trail heads south through Seacliff, the trail route will be located on the ocean side of the railroad tracks. This presents some challenges since portions of the corridor through this area are very narrow. The plan states:

The rail corridor along the length of Poplar Street to Mar Vista Drive is just 34 feet wide. The trail would be forced between a narrow landscape buffer between Poplar Street and the railroad corridor. The trail alignment would continue down the coast side of the tracks after crossing the Mar Vista Drive intersection using the existing crosswalks. Crosswalks and possibly the intersection corners would need to be modified to provide a safe crossing for bicycles and pedestrians.

The County's extensive study of possible paths to walkable communities, with plans to locate housing and jobs together to promote village creation and the specifics of sustainability in Santa Cruz County continues on its multi-year path. Public workshops in October drew out community visions of sustainability. The next step is for the advisory group and public to attend a Planning Commission public meeting December 12th for a "study session." Land use focus areas will be discussed in light of alternative land uses, densities, circulation options and site design choices. Seacliff residents are encouraged to attend:
