In its 32nd year, the Human Race Walkathon & Fun Run is a nationwide community fundraising event for non-profits. It provides an opportunity for all sectors of the community to join together for a common purpose --- sustaining vital community services and programs.

Last year we achieved our goal of \$2,000. Our goal in 2012 is \$2,500. The money will be used for our activities and events including improving and maintaining our many Seacliff gardens. The association receives 75% for every dollar raised, and the Human Race organizers receive 25% to stage and coordinate the event.

Take our Seacliff Village Survey Will Roblin

The Seacliff Village Plan Committee continues to promote improvements in the village on several fronts. Committee members, Ben Strock, of Strock Real Estate, and Cole Strickland, whose family runs Forget Me Not, are providing us with the merchant perspective of the village. The committee has also met with other property and business owners for their input.

There were many ideas recorded in the original village plan but that was over a decade ago so we need a fresh look at what the community wants. The results of the survey will be included in our report to the county at the conclusion of the plan review and be promoted to those wishing to develop properties or open businesses here.

Our committee members are also busy pursuing completion of the village utility undergrounding. With the sanitary sewer upgrade complete, utility undergrounding is currently reported to start in the Fall of 2012. After that phase of work, the streetscape improvements of sidewalks and crosswalks could begin.

Scenic Trail Input Needed

Over 200 people attended recent workshops to discuss the proposed coastal bicycle/pedestrian trail network project. The future trail will serve transportation, recreation and interpretive uses for walkers, joggers, bicyclists, families, locals, and visitors. Topics raised during the public workshops are being considered as part of identifying potential trail



alignments for the Draft Trail Network Master Plan. The Draft Plan is anticipated to be released this upcoming summer.

Since the trail passes through Seacliff, please review the "Opportunities and Constraints" map: http://sccrtc.org/projects/multi-modal/monterey-bay-sanctuary-scenic-trail/opportunities-and-constraints-analysis/ to see what has been proposed. The purpose of the map is to translate the technical information gathered into a tool to guide the identification of potential alignments. Final draft alignment maps will be provided in the Draft Master Plan and feedback will be solicited at that time.

Sierra Northern Railroad's withdrawal from their interest in serving as the local Shortline Operator may delay acquisition of the Santa Cruz Branch Rail Line; however, the rail right-of-way is one of the various potential alignments under consideration and the Monterey Bay Sanctuary Scenic Trail Network planning will continue as planned. After release of the Draft Monterey Bay Sanctuary Scenic Trail Master Plan and the Draft Environmental Impact Report (EIR), a second series of public workshops will be held to receive input into the draft documents and confirm the route alignments. Final adoption of the Master Plan and EIR is expected in early 2013.

Park Funding Begins

Supervisor Ellen Pirie has established a county fund to be used exclusively for Seacliff's first neighborhood park at the corner of Searidge Drive and McGregor Road. A hefty \$635,000 from the recent sale of the Polo Grounds Park water well has been deposited in the account.

Following the association sponsored public park design workshops in 2009, Bob Olsen, the Department of Public Works, Parks Division Planner, has been able to complete eighty percent of the applications and design details. By the end of April, the Parks Division will contract with a consultant to finish the remaining twenty percent. The project will then be submitted to the Planning Department. If the permit process proceeds smoothly, all permits should be ready before the end of 2012.

Bob is analyzing ways to best stage the phases of the park's construction. The first components will require engineering to grade the 1.25-acre lot and to build an erosion-control retaining wall along the Sea Ridge Road bluff-side of the lot. Also included in the infrastructure phase will be the installation of water lines, paved parking and walkways.

The total cost from infrastructure, permits and analytical reports to play equipment and planting is estimated to be \$1.7 million. The \$635,000 fund should cover most of the design, site preparation, utilities and hardscape.

The McGregor park site is currently in the top tier of consideration by the State for "The Urban Greening Grant for Sustainable Communities" a Proposition 84 program passed by voters. The grant application is for nearly \$1-million dollars and we should hear the results in the early Spring. The Parks Division is also checking into a range of other Stewardship grant opportunities.

By the end of April or May 2012, the Parks Division will convene with the Seacliff community to create a private fundraising campaign to complete the park. Discussion of a name for the park will be a part of the public process.

Help Prepare for Disaster



Seacliff has an active Community Emergency Response Teams (CERT) Program but we need your help to increase the number of people certified.

Following a major disaster, those who provide fire and medical services may not be available. Factors as number of victims, communication failures, and road blockages will prevent people from accessing emergency services they have come to expect. Residents will have to rely on one another for help. CERT is designed to help neighborhoods prepare for effective disaster and emergency response through training and pre-planning.

The training covers basic skills that are important to know when emergency services may not be immediately available. Program material covers earthquakes, fires, floods, hazardous incidents and other general life-threatening situations. Training lasts about 20 hours, divided over 6 evenings. The training increases one's ability to safely help their self, family and neighbors.

Here is where you can help. We need an additional 37 individuals to support our community by becoming CERT qualified. Now is the time to prepare and get ready! Please, contact Mary Edmund at phone: 475-2633 or email: medmund4@yahoo.com for more information.
