CSAs - Another Road to Improvements Zach Friend Second District Supervisor County of Santa Cruz

A simple walk through Seacliff will show that the condition of our local roads is deteriorating. The County recently completed an analysis of our local roads to determine just how bad it is. On a scale of zero (a failed road) to 100 (new road) the average Pavement Condition Index of Santa Cruz

County roads is 55. This means that our roads are generally defined as being in "poor condition" by this state measurement index. The deferred maintenance for Santa Cruz County roads is estimated to be approximately \$180 million over the next five years. With state and federal funding for road repairs drastically cut over the last decade and local funding mechanisms unable to keep pace with the growing need (only 13 cents of our local property tax dollar comes back to the County), how do we address this problem?

One option is through expanding County Service Areas (CSAs). These are small neighborhood or rural roadway benefit assessment areas that raise funds to build, maintain and repair roads specific to your neighborhood. The CSAs are self-initiated and are set up under Prop. 218 and require a mail ballot procedure and majority of the returned votes. This is a way to ensure that your specific local road is addressed.

Residents organize to form the service area and determine the benefit assessment rate that they wish to assess themselves to finance a specific service, such as road maintenance. One of the major reasons to form a CSA is to provide an effective mechanism to collect benefit assessments from all property owners in an area that benefits from the specific services provided. The annual benefit assessment appears on each parcel's property tax bill. All of Seacliff could form a CSA or just the residents of a specific street or set of streets. Here are the steps:

- 1. An application and petition is obtained from (and submitted to) the Local Agency Formation Commission (LAFCO). Generally, it is recommended that at least 2/3 of the affected property owners desire the formation of the service areas; having the initial support of a large portion of the residents will help to ensure smooth operation of the service area in the future.
- 2. County Public Works researches the area and prepares a map and legal description of the proposed service area. This step can be performed by a private consulting engineer if the residents desire to do so.
- 3. The map, description, application, and initial deposit are submitted to LAFCO. LAFCO reviews the proposed boundaries of the CSA to determine that all parcels that will benefit from the CSA are included and any that won't benefit are excluded. LAFCO will advertise and hold a public hearing to determine the final CSA boundary.
- 4. Public Works submits the LAFCO-approved boundary to the Santa Cruz County Board of Supervisors. The Board will advertise and set a date for a public hearing on the formation of the service area. After the hearing the service area is approved or the process terminated. Concurrent with the CSA formation, Public Works will request the Board of Supervisors to initiate the benefit assessment rate proceedings in accordance with Proposition 218 ballot proceedings. In other words, a mailed ballot will be sent to the affected property owners to set the initial rate and formation.
- 5. Public Works submits the map and description as approved by the County Board of Supervisors to LAFCO for the State Board of Equalization and LAFCO records the service area and forwards the necessary information and the filing fee to the State Board of Equalization (SBE). After filing with the SBE, the formation process is complete.

Once a year, the CSA must hold a meeting to establish benefit assessment rates and a work program. Based on the property owners wishes, the Board of Supervisors then sets the rates and approves an annual budget for the CSA. The benefit assessments are collected on the regular property tax bill in December and April each year.

While no one likes the idea of additional property taxes, one key advantage of this process is that these taxes stay in your neighborhood or even your street (depending upon size of the CSA). In other words, your assessment will specifically lead to the repair and maintenance of your own road and/or neighborhood roads.



Sustainable Santa Cruz County Update Will Roblin

Last month, Sustainable Santa Cruz County (previously-known as the Transit Corridors Plan for Sustainable Communities in Santa Cruz County) presented a preliminary view of transportation and zoning changes to area planning commissioners, members of the Regional Transportation Commission, the City of Santa Cruz and an advisory group that includes delegates from neighborhood associations like ours. The goal of the plan is to establish a community-based vision for a more sustainable way-of-life in Live Oak, Soquel, and Aptos. The plan will integrate land use and transportation policies in a way that protects environmental resources, supports economic growth, and increases access to opportunity for residents.

Collected from input gathered at three public workshops conducted last year, residents' ideas and suggestions have now been incorporated into the plan. Neighborhood maps are now overlaid with existing zoning and with conceptual changes including new streets, property rezoning, and expansion of the county General Plan Land Use Designations to meet the project goals.

Aptos has been identified as a Traffic Study focus area that encompasses Cabrillo College to Trout Gulch Road along both sides of Highway 1 and Soquel Drive. There are no plans for land use zoning changes here. The current draft plan includes two new potential highway crossings at Cabrillo College and Mar Vista Drive along with the pedestrian and bicycle bridge proposed previously. It also includes plans to use an existing crossing at the railroad bridge over the highway at the east end of North Avenue and Aptos Wharf Road for pedestrian and bicycle access. These concepts will receive more complete review in June. The Sustainable Santa Cruz County study is set to complete its work in 2015. Read more about it at: http://transitcorridorsplan.org/

The Latest on the Downtown Seacliff **Undergrounding and Streetscaping**

After resolving issues with the bidding contractor, the downtown village utility undergrounding project is once again proceeding. It was delayed through the second half of 2013 after two rounds of contract bidding yielded unacceptable results. The utilities have now applied to the Regional Transportation Commission for easements to work under the rail line along State Park Drive and, after consulting with Iowa Pacific, the RTC board will hopefully vote to approve them. This may take two to three months but the utilities hope they can proceed on the undergrounding while waiting for this approval.

AT&T expects their piece of the undergrounding to take 6-8 weeks but PG&E expects to work through 2014. PG&E is also working with the Santa Cruz County Department of Public Works to coordinate undergrounding work with the upcoming streetscaping project. Things like power lines for the streetlights, etc. need to be in place for the streetscaping to proceed.

Streetscape Update

The Santa Cruz County Department of Public Works has been planning a beautification of downtown Seacliff for over ten years. There have been many challenges with the project but most of them have been overcome with just a few remaining to be resolved. Part of the project is on land owned by California State Parks and must be approved, including easements, before the work can begin. After working with the county to resolve issues with design elements, State Parks now has the final draft plan for their piece of the streetscape plan. Once they approve it, and complete a property assessment, the project can begin.

There will also be one final public meeting to finalize plant selection. The project landscape design firm has created a suggested palette of plants that will be suitable for the site. Plants, including drought tolerant natives, will be chosen so that, once established, they will require little water and maintenance. We will announce the meeting date for this meeting later this year.

Park for Seacliff Imminent

A ground-breaking for the construction of the long anticipated neighborhood park in Seacliff is likely this summer, according to Sheryl Bailey, the Park's Project Manager with the Santa Cruz County Department of Public Works, Parks Division. During the latter part of 2013, Shervl and her design team incorporated a list of changes requested by the Santa Cruz County Planning Department and other reviewing agencies.

In January, the neighborhood park plans were re-submitted to the Planning Department. The review by the Planning Department should take about 30 days and no additional issues are anticipated to further stall construction of the park. This is very good news for Seacliff.

The neighborhood park has been on the drawing board since 2007, when the County purchased the 1.25-acre site from South County Housing Corporation, the nonprofit organization that has recently completed building the Canterbury Park townhomes adjacent to the park.

Phase I of the Park's construction will include installation of a playground for young children; a picnic table area; a permanent turf lawn; a portion of the park's walkway; drought-tolerant landscaping; and a temporary restroom. A new sidewalk will connect the corner of Searidge Road to the Canterbury Lane-McGregor Road intersection.

Private donations will be needed to complete the park's Phase II installation of the permanent restroom, skateable art piece and the corner amphitheater,


Seacliff CERT now 5 years Old and Growing!

The CERT Program educates people about disaster preparedness for hazards that may impact their community. CERT trains volunteers in basic disaster response skills, such as fire safety, light search and rescue, team

organization, and disaster medical operations. Using the training learned in the classroom and during exercises, CERT members may assist others in their neighborhood following an event when professional responders are not immediately available. Training lasts about 20 hours, divided over 6 evenings. The training increases one's ability to safely help themselves, family and neighbors in the event of a crisis such as an earthquake, wildfire or severe storm.

Seacliff CERT was formed 5 years ago when members from the SIA Board of Directors took the certification training. Since then it has grown to 25 residents who are divided into 6 regions based on their home addresses:



Our goal is to provide communication to Seacliff residents by gathering information about the event from outside the community and sharing those facts within the community. We meet quarterly to build cohesion and provide refresher discussions.
