Hello and Happy Spring! Please be sure to attend our next special event general membership meeting Wednesday, May 10th at 7:00 p.m. at the Aptos Library. Our first featured speaker will be John Hibble, our Aptos Chamber of Commerce Executive Director, and now also, Museum Curator of the new Aptos History Museum. He'll tell us a story or two about our fascinating local Aptos History! Following John Hibble, our Seacliff neighbor, Doron Fishbin, a Land Use Development Consultant, will discuss his plans for developing two vacant lots in downtown Seacliff! One of the developments is on the corner of Broadway and North Avenue and is planned to be a two-story building of ten small vacation rentals with a small, attached restaurant. The other property at Center and Broadway is still in escrow, and Doron hopes a New Leaf Market will occupy this space on the 1st floor and the 2nd floor be occupied by combined office/living space condominiums. Their architecture will be similar to 1920's style building of Hwy 1 Pizza and Aptos Pet Grooming on Center Street, and help unify the appearance of downtown Seacliff. We'll begin with refreshments so please plan to attend this special event, learn a little news about your community, and meet a few neighbors!

The <u>anticipated</u> construction completion date is July 15, 2006.



The project is funded with several government agency loans and specific income and maximum

Seacliff Village Plan Update

You may have recently seen your Seacliff Improvement Association Board members out in your neighborhood asking for petition signatures to request PG&E amend their 2006 budget to include funds for designing the undergrounding of the utilities in downtown Seacliff. Our industrious board collected 200 signatures from Seacliff residents and merchants! This petition was sent with a letter from our association, a separate letter from the Aptos Chamber of Commerce, and a letter from County Supervisor Ellen Pirie all requesting PG&E amend their 2006 budget. Although this year's budget may not be changed, our chances for inclusion in the 2007 budget are excellent. In addition to this project, the County of Santa Cruz will build a sewer line in our downtown area that will connect to the line that currently runs from New Brighton Beach. This \$15M project also must be completed before the downtown streetscape can begin. Currently there is \$5-\$6M allocated. The remaining funds can be acquired with a low interest loan. But Public Works is pursuing grant money since a loan would affect our sewage rates. Construction of the sewer in downtown Seacliff may begin as early as Spring 2007.

Par 3 Development and Seacliff

Many Seacliff residents expressed concerns about the development plans for housing on the Par 3 property that runs along Highway 1 between the Seacliff Inn and Mar Vista Drive. So, at our last membership meeting Jan Lindenthal, of South County Housing, and Peter Dunne of Standard Pacific Homes were invited to show slides and discuss their portions of this development.

The audience was impressed with the thorough planning of current and future South County Housing projects, however, the drawings of the planned three-story Par 3 development that Standard Pacific has designed concerned many in the audience because of the density of the housing and lack of creative design. In addition, Peter Dunne said little to allay the audience concerns of increased traffic that will occur in the area of Soquel Drive and State Park Drive if this 211-unit development is built.

Currently, there are several incipient protests of the Par 3 planned development. One is a petition from local citizens requesting that the Santa Cruz County Supervisors not approve the rezoning of the property. Another objection may come from the Santa Cruz County Parks Commission. They are considering the ramification of rezoning the Par 3 parcels from Parks, Recreational, and Open Space. This commission expects to vote May 8, 2006 whether to recommend that the Santa Cruz County Planning Commission and the Santa Cruz County Board of Supervisors deny the current Par 3 application to rezone the parcels. Or, the Santa Cruz County Parks Commission may vote to recommend a denial and return of the submitted site plans to the applicant for re-consideration.

Another idea is to use redevelopment money to purchase the property and put about half, or 105 affordable housing units on this property with the remainder of the property to be designed as a public park. We'll keep you advised of these developments and when and if an Environmental Impact Report is published, the period open for public comment.
