Seacliff Village Improvement Projects Hit a Snag

Village residents encountered new obstacles on the path to some long-awaited improvements earlier this month when the County Public Works Department discovered that, just two weeks prior to construction, the portion of the design on State Park land had moved forward without securing an easement. Additionally, the parallel project of undergrounding of utility poles in the village also proceeded without the advance work of securing all easements. While responsibility for these oversights varies, the association is pressing all parties to quickly resolve these issues.

How do easements through State Park land hold up sidewalks in the village? Construction needs to begin at the lowest part of work and move upward. Any trenching, installation of pipes and utilities must precede sidewalks and landscaping. It is unclear whether some phase of the work can occur to allow undergrounding to proceed in the village on county streets while the easement issues on State Park land are resolved.

County Public Works and State Parks also recently found that they were not in agreement on the street design for the village side of State Park Drive. The two parcels involved are located along the east side of State Park Drive and include the corner "triangle" and the dirt parking lot at the corner of State Park Drive and Santa Cruz Avenue. State Parks would like to integrate the entry into the park with the county's plan. Conceivably, this design re-do could occur during the resolution of the easement issues to avoid a double delay. Association representatives are actively working to assist State Parks and the County toward a resolution that serves visitors, and Seacliff residents and businesses.

Seacliff Mural Project

This newly formed committee of the Seacliff Improvement Association will create the organizational framework necessary for this ambitious project. Project organizers will locate potential sites and develop a



concept for each mural. We seek volunteers to work on site selection and preparation, mural themes, event planning and promotion. The mural project coordinators hope to join talented artists, business owners, local schools, and residents together to create the murals to enhance and beautify our coastal community.

A field trip to Watsonville is planned to tour the Historic Label Art Murals in Watsonville: We will meet in front of Forget Me Not Clothing and Manuel's Mexican Food Restaurant, near the triangle at the entrance to Seacliff Beach on September 29th at 9am. Carpools are welcomed and encouraged, as well as a good pair of walking shoes. Walking tour guides will be provided.
