2024 Aptos Village Pedestrian Survey



Conducted From June – August 2024 by the Seacliff Improvement Association Aptos, California One of the tenets of the Seacliff Improvement Association is to work with local government agencies to improve infrastructure for our community. This includes safe passage throughout our Seacliff neighborhood and to the rest of Aptos.


This summer we conducted a survey of our members and other Aptos residents to determine the interest in and need for safe pedestrian passage to Aptos Village. This follows an identical survey we conducted in 2017 that prompted our community stroll to the newly installed Aptos Village Green in 2019. Our goal was to support new and existing village businesses, bring attention to the challenges of walking to Aptos Village from surrounding neighborhoods, and demonstrate the importance of creating safe passages for pedestrians throughout Aptos.

The Village has grown a lot since 2019 but not much has improved for pedestrians and, not surprisingly, respondents to our 2024 survey overwhelmingly expressed a desire to be able to walk and cycle safely from the surrounding areas to Aptos Village.


Of the 304 respondents, 45% stated they traveled on foot or on a bicycle, an increase of 5% from our 2017 survey. The main hazards they encountered are shown on the chart on page 4 and most can be remedied by road improvements to these routes. The other charts following this page show the survey results with some responses aggregated into similar categories for clarity.


The completion of the Aptos Village Project, adding businesses, restaurants, housing and services, will only increase the need for alternatives to driving. Those who have attempted to walk, ride a bike, use a stroller, a walker or a wheelchair anywhere along Soquel Drive to reach Aptos Village, have likely experienced the stress and challenge of navigating to their destination. This narrow, long neglected segment of Soquel Drive carries part of the daily commute through Aptos, often in standstill traffic, along with children on foot, bikes and skateboards traveling to Valencia Elementary, Aptos Junior High, and on to Aptos High School. Aptos Village was developed to encourage the use of nearby transit and, with expanded and more frequent METRO service now running along this corridor, providing safer routes to transit stops will encourage more residents to ride the bus.


Aptos residents have been very patient over the years as studies and plans were developed. Regional and County long-range plans for Aptos have included the Monterey Bay Sanctuary Scenic Trail Network, the Aptos Village Plan, the Sustainable Santa Cruz County Plan, the Unified Corridor Investment Study, and, most recently, the Watsonville-Santa Cruz Multimodal Corridor Program. All are important and construction of Segment 12 of the Scenic Trail will bring more people to the area requiring commensurate safety infrastructure to accommodate them. The village businesses depend on the ability of customers to reach them. People walking, using wheelchairs, and cycling need much less space than vehicles and should receive the same safety measures as those who drive. Drivers need roadways clearly marked and separated from everyone else where possible so they can better navigate through this congested area safely. The sooner these are installed, the safer Aptos will be for all of us.





If you did travel, why did you go to Aptos Village (choose as many as apply):
























All respondents were asked to provide general comments. These were combined into categories followed by the individual answers.





	Individual Comments:		
1	Although there is no sidewalk along the aptos creek end of center street, I still walk along center to the Seacliff village. But the lack of sidewalks on Spreckels and the typical traffic speed makes it too dangerous to walk to aptos village.		
2	All this building and not one bit of consideration to safe walking		
3	A trail following the railroad tracks would be ideal. Away from cars and less road noise.		
4	Aptos desperately needs better multi-modal transportation access and support.		
5	Aptos Village's layout and amount of traffic does not make walking there enticing. Neither does the amount of trash on the streets along my walk. It would be GREAT if it was more pleasant (visually and safety) to walk there!		
6	At a minimum brush and debris could be removed to make it safer for pedestrians		
7	Build the rail trail		
8	Building a trail with some outlets along the railroad corridor would be very SAFE.		
9	Car speed is a huge issue. Why are cars allowed to exit and enter at Caroline's?, off trout gulch Really dangerous. So many issues with Aptos village. We walk everyday around here.		
10	Concerned about parking space availability in Village once construction finished. Already people are parking cars on Aptos Creek Road past the Soquel Creek Water District area making it difficult for residents and/or visitors to drive on narrow road. Also. Safety issue as first responders, including fire trucks, might not have enough space to drive through.		
11	Crossing Aptos Creek Bridge by cycle is very tricky. I'm comfortable with doing it, but not everybody is, autos need to be educated about the pavement sign of allowing bicycles in the full lane not sure there's much you can do in terms of physical plants/structures to improve transit across the bridge for pedestrian /cyclist.		
12	Crossing Highway 1 on foot is frightening		
13	Don't feel the need for sidewalks but think bike lanes would be good		
14	Help!? I'd like to be able to do more errands by walking, but especially with a child or 2 along it's too hazardous		
15	Hoping and wishing, maybe even praying for a bike path		
16	How can we deter mountain lions and coyotes from coming into our housing communities?		
17	I also walk Seacliff to Rancho Del Mar on State Parks over the freeway. Almost was run over by a car that ran a red light and ignored pedestrian crossing.		
18	I am not sure that the current design on the pedestrian bridge at Mar Vista will actually help with this problem. The ramps are very long making the walk long. There is no options to use stairs instead of walking the long ramps. It takes to you a road that is biased away from Aptos Village. Who comes up with these brilliant ideas?		
19	I am not sure what you mean by safer. To me, safer means no toxic exhaust car fumes from any roads. So if this whole area were immune to that, I would walk more. It's a truly wonderful area where so many things are close by so I wish that could be so but seems unrealistic.		
20	I can't wait for this project to get completed. Currently, there is no safe way to travel to Aptos Village by foot or bike.		

Individual Comments:		
21	I definitely wish Aptos had a severe walking/biking trail or route. It seems like the natural environment to foster that kind of community activity, but the safety issues hamper it.	
22	I go to the Village every single day, but I usually drive because it is just not safe to walk or ride the 1/2 mile from my home.	
23	I have been out of town but I walk and bike in Seacliff all the time and bike to Aptos. I find it quite safe, although Soquel drive is quite busy.	
24	I have mobility issues otherwise I would walk or bike	
25	I live in Seacliff and the village is too far away to walk to.	
26	I live on Sea Ridge road and I typically visit businesses towards the west on foot or bike because they feel safer, however it is more limited. With the walking trail, my family and I would be much more inclined to visit Aptos Village on foot or bike if it felt safer.	
27	I live too far to walk/bike but would love to have safe options to do so if I were to move closer. Thanks!	
28	I love walking and love this village	
29	I love walking. I'd love a nice wide walking and biking coastal trail that was wide and safe and available now. Thanks.	
30	I only walk to Aptos village now but would love to be able to walk and ride my bike on a car free path. Right now, I only ride my bike in Seacliff due to traffic on State Park bridge and Soquel Drive.	
31	I sometimes go via Sea Terrace Way, Seacliff, Santa Clara, Center, State Park Drive, Soquel Dr. much longer but maybe safer.	
32	I tried walking several different ways. I was almost hit by a car on the State Park overpass and had two close calls walking on Spreckels.	
33	I want the rail trail so I can take the trail to Aptos Village and even catch a commuter train to my job in Santa Cruz. No more cars!!	
34	I would be there regularly if they got rid of that idiotic train idea and turned the corridor into a trail. Why do we have to waste hundreds of millions of dollars on a trail that prioritizes a train that first exist and at best, may exist 4 decades from now. I will not be here and most of the businesses that need our support won't be here by then but right now it is simply too difficult to use a car in the village and too deadly to get there by foot or by bike.	
35	I would take a train on the rail/trail to Aptos.

37	I'm in a wheelchair and find it almost impossible to go down center avenue. The steep pitch of the road, cars parked, (my neighbor running a used car lot), cars speeding and rocks along the side of the street make it difficult for my health care aid to take me for a walk. I've almost been dumped out of my chair a few times.	
38	I'd love to be able to walk down by what used to be a pathway beside the beach at Rio Del Mar. I used to park my car in the Rio del Mar parking lot & walk along the pathway that leads toward New Brighton Beach a few times a week. Sadly, with all the storm damage, that's no longer possible & may not be for some time. Unlike Capitola, Aptos isn't a city & SC County has many other disasters areas to contend with, so I expect there won't be a pathway any time soon. Onward we do what we can.

55	Many Seacliff neighbors are not provided with On Street parking. They're allowing their bushes and hedges to grow onto the 40 foot road right away, preventing people to walk, ride their bikes, walk their dogs, and children, safely. Many of the neighbors ignore this and continue to use this public right away for their own private yards and use.

95	Walking from Rolling Green Estate to the village there is little sidewalk on a busy road	
96	Walking in Seacliff; say, from Mar Vista to State Park and down to Manuel's, is almost impossible. Add in the rude children on e-bikes and you have a disaster waiting to happen.

98	Walking to Aptos Village on Spreckels isn't safe. The State Park Drive bridge is very narrow and close to cars. The intersection of Spreckels and Soquel isn't safe for pedestrians. The Aptos Creek Bridge is too narrow for strollers and wheelchairs. Walking on the bridge is scary because the sidewalk is too narrow and close to cars.
