

Q1: How likely would you be to use passenger rail service in Santa Cruz County?





Q3: How do you think passenger rail would impact the overall quality of life in Seacliff?









Q6: Do you think our association should take a position on passenger rail service running through Seacliff?




Q7: If our association were to take a position, should we:

- thank you for doing this survey. I do not think it is at all practical to put a train through this already congested town and the cost would be ridiculous. Perhaps some other type of transportation on the trail for those who can not use their electric or manual bikes etc but more creative ideas needed than a train stopping particularly in norther parts of santa cruz Our impact would be less in Aptos, but I don't see that it is cost effective with so many new modes of transportation and does not help the workers coming from Watsonville likely as most need their equipment etc. But a rail or better transportation from MOnterey/ watsonville is definitely needed but within town just seems impractical and don't think going north on 1 is needed beyond santa cruz. More efficient bus within Santa cruz popular stops is needed for beach goers and shoppers etc (that doesn't stop every block and take 45 minutes when get dropped off from 17 express bus drop off to Aptos)
- The cost of the Passenger Rail Service should be applied to improving our roads across the county. Our roads are poor. When traveling through they are often congested because the roads are badly planned going from one lane to two lanes to one lane constantly. We also need another bridge across the Soquel river to improve travel across te county. There are lots more improvements to discuss. Improve town planning would help

- I travel outside the US around 4 months a year. My preferred method of travel is trains. They are quiet, punctual, safe. And environmentally friendly
- Pull the tracks, recycle them and create a trail Already! Let's get this County moving in an inexpensive and effective fashion ASAP.
- We have a lovely peaceful environment with Wildlife habitats and greenery. I can't even imagine why anyone would want this disruption and expense. Also our taxes are already off the charts. Who wants to pay more for a rail that only worsens our quality of life and lowers our property values. Commuters can ride a bus.
- The RTC announced yesterday that it will cost \$1 BILLION to build the required new rail bridges. That estimate covers NOTHING else. Who will pay for this? Who will pay for the fact that fairs will NOT cover the operating costs? Who will pay for ongoing maintenance. NOBODY. The county is broke. The state is in no position to pay. And it sure as hell is not coming from Trump. The trail could be done quickly and inexpensively. It would be a big draw for visitors and tourists. NOBODY will want to walk or bike alongside of the trains. When will there be one ounce of reality in these discussions?

Comments:

- A trail only would be much more of an enhancement to the area.
- The concept of this train is incredibly ridiculous and will cost an insane amount of money. This entire project needs to be investigated .
- Trail Now. Only viable option for a train is to go up like an L train in Chicago (trail under). There will not be \$ for that but the trail could start with that option for way into the future. No room for side by side. And traffic when a train comes through in any part of SC county is horrendous.
- I like the idea of passenger rail service and believe I would use it but it would have to be frequent enough to be useful, and cheap enough that it would not raise taxes to an unreasonable level (subjective I know, but many here are retirees or young families) especially now as a recession is predicted. Bad timing perhaps?
- Support passenger rail service with connections to California State Rail. Public rail transit. like parks & libraries, should be available for every person. Any
 truly civilized society would provide this without reservations as a matter of humanity. We need to evolve in this direction. Rail line is the last open corridor
 linking north to south. More housing is being built and our streets, roads and highway experience gridlock.
